Per Chapter 39.80 RCW this is a Qualifications-Based Selection. Proposals should not include any references to fees or costs.

We request that submittals be limited to no more than ten (10) single-side or five (5) double-sided pages for the project plus any general firm information and photographs. Please submit one (1) original, four (4) copies, and one (1) digital version of your proposal.

Submittals will be evaluated and ranked based on the following criteria:

- 1. Key personnel
- 2. Firm experience
- 3. Ability to meet schedule
- 4. Approach to project
- 5. Familiarity with relevant codes and standards, especially ADA regulations
- 6. Experience with Park and Ride development
- 7. Approach to landscape, hardscape, and urban design
- 8. Experience with stormwater modeling and bathroom design along with related septic design
- 9. Familiarity with WSDOT standards
- 10. Past performance/references

Jefferson Transit will base its selection on the strength of the proposal alone. The criteria listed will carry equal weight during the selection process. Transit may choose consultants form the submitted proposals or may choose to shortlist and conduct phone or in-person interviews for any or all proposals. Firms should be prepared to have the project manager and key personnel present their proposal in an interview by Transit staff, if necessary.

Jefferson Transit encourages disadvantaged, minority, and women-owned firms to respond.
